PASR is your legislative watchdog and the advocate for school retirees. It has been tireless in its advocacy for the 37,000 members who have not received a COLA since 2001. Unfortunately, *unlike many other systems, any adjustment to PSERS needs legislative approval*. PASR is, therefore, asking you to help to convince lawmakers of the need for a COLA. *If you receive an email from PASR asking you to contact your state legislators, please consider acting on that* 

request promptly. Your representative's or your senator's support may be crucial and your communication with your elected representatives will have an impact on PASR's efforts to secure a COLA for PSER's annuitants.

If you are not currently a member of the PASR state association please consider joining now. State membership opens the door to additional benefits like insurance, product and service discounts, PASR legislative updates and travel opportunities. Some of the more popular benefits are dental, vision and hearing services. Click on Join PASR on the PASR website home page and become a state member today. State dues (\$60.00) are paid each year based upon the month you join.

## **SPRING LUNCHEON**

Our joint Bucks-Mont Luncheon was held on May 4 with Montgomery County Co=President, Evelyn Reese presiding. Highlights of the program were the presentation of the Montgomery County Teacher Grant and 4 student scholarships awarded from both counties.



In 2023 Montgomery County received \$750 from Region 1 Educational Support Committee. The recipient of the award was Dr. Deborah Broderick, Director, of the Teacher Academy at Central Montco Technical High School. Dr. Broderick developed a program for students interested in pursuing a career in education. The students receive classroom instruction in English composition, tailored for teachers and Foundations of Education. They also have classroom experience in both elementary and secondary education and a third unit of their own choosing. They are able to receive college credit for the classroom instructions.

Montgomery County awarded scholarships to Raina Conaway who is pursuing a career in Library Science at Kutztown University and Laura Kirsch who will be attending Indiana University of Pennsylvania for Early and Special Education. Both girls are from the Hatboro-Horsham School District. Raina worked with kids ages 4 – 14 teaching them how to code and Laura was part of Helping Little Hands program



Bucks County awarded Niamh Keegan from Council Rock a scholarship to Pennsylvania State University for Special Education. Her personal experience

of benefitting from an IEP led her to pursue a career in special education. She was part of the Buddy Club that assists special needs kids. As part of this she planned activities for 30 students. Hailey Salvatore from Central Bucks South received a scholarship to attend Gwynedd Mercy College also in the field on special and early childhood education. As a kid she taught her "American Girl" Dolls and has been tutoring autistic students during her high school.

The new by-laws for the Bucks-Montco Chapter were presented for member's perusal. They will be formally accepted at the Fall Luncheon when

our chapters were be officially joined.
